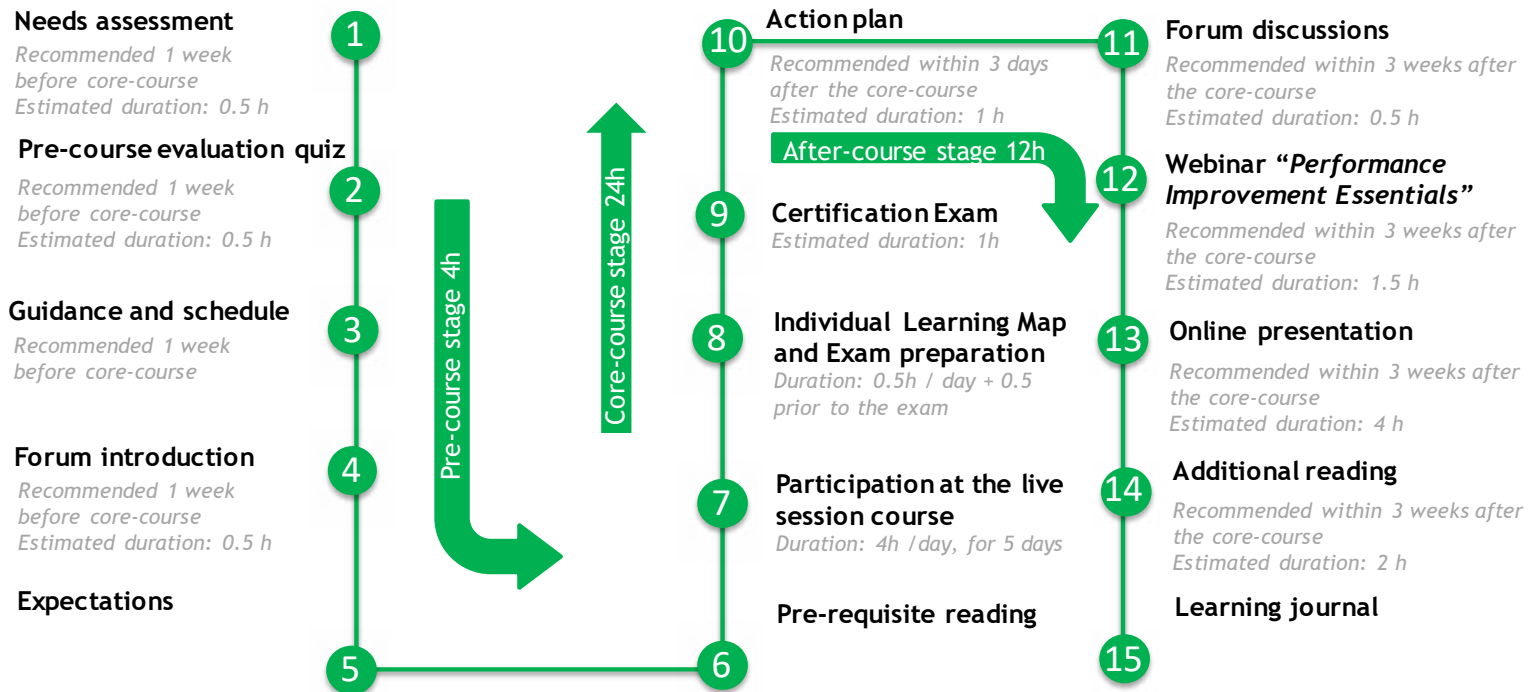

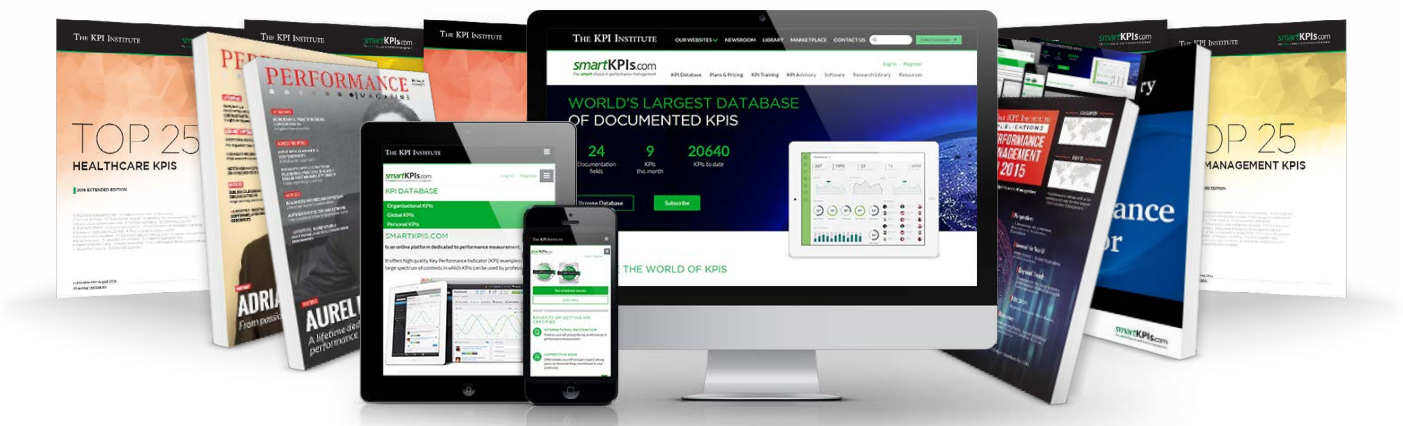
# Certification Process

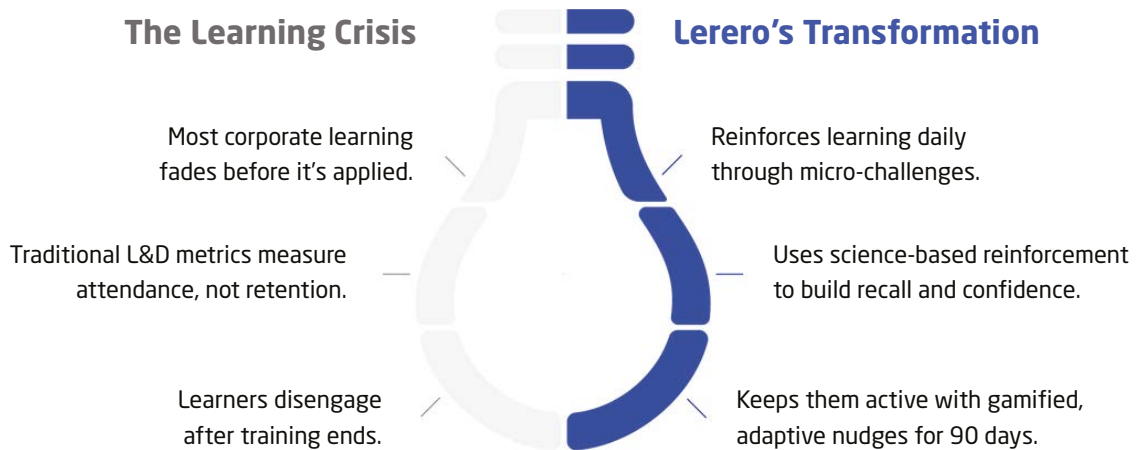
